SME INTERNATIONALIZATION VOUCHER 2025

Applications can be submitted from 12:00 PM on November 28, 2024, until 5:00 PM on January 15, 2025.

Objective:

To support the participation of regional SMEs in international trade fairs in order to expand their access to foreign markets and promote their internationalization processes.

Beneficiaries:

SMEs registered in the Italian Business Register, actively listed there, and with one or more operating offices in the Lazio region.

Contribution:

A grant of **€15,240.00** for each international trade fair attended by the beneficiary SME. Each SME can receive funding for a single project, as an individual applicant, to participate in up to a **maximum of three international trade fairs**, which must all begin after the publication date of the notice and conclude by December 31, 2025.

Disbursement Method:

The contribution will be disbursed as a balance payment, in a single instalment, upon submission of a disbursement request. This request must be submitted no later than two months after the conclusion of the last international trade fair covered by the contribution.
